

With the support of the Mediators Association of Georgia and the European Law Students Association (ELSA Georgia) a joint event "School of Law and Competition in Mediation" was organized.






Irakli Kandashvili, Chairman of the Mediators Association of Georgia, awarded the winner students participating in the essay competition.

By the support of "Mediators Association of Georgia" and by hosting of University of Georgia, for the first time in Georgia, is held an international mediation competition organized by the International Academy for Dispute Resolution (INADR) - INADR International Law School Mediation Tournament. The annual International Mediation Competition brings together the law school students and alumni from around the world.



Within the framework of the memorandum signed between the Mediators Association of Georgia and Ivane Javakhishvili Tbilisi State University, was held 35 hours Online training for student teams of 8 higher education institutions of Georgia. The event organized by the National Center for Alternative Dispute Resolution (TSU NCADR) with the support of the East-West Management Institute and the Rule of Law Support Project (EWMI / PROLoG).






A training on the topic "Negotiation Techniques for Mediators" was held for the members of the Mediators Association of Georgia.

The training was conducted within the framework of a memorandum signed between the Mediators Association of Georgia and Ilia State University.

Within the framework of the memorandum signed between the Mediators Association of Georgia and Tbilisi Open University, a discussion / round table was held on the topic - "Comparative advantage of substantive-procedural guarantees of court-private mediation in the context of business dispute".



A working meeting / discussion was held- Mediation - An Alternative Dispute Resolution Mechanism in the Business Sector. The meeting was organized by the Mediators Association of Georgia and Global Compact Georgia Network.





An online meeting was held with the support of the Mediators Association of Georgia, the Network of Centers for Democratic Involvement and USAID / PROLOG: Mediation - a new dispute resolution mechanism in Georgia. In the meeting participated the representatives of the network offices of the Centers for Democratic Involvement from Akhaltsikhe, Batumi, Gori, Kutaisi, Marneuli, Ozurgeti, Rustavi, Sagarejo, Telavi and Zugdidi.

The General Assembly of the Mediators Association of Georgia was held.

Irakli Kandashvili, the Chairman of the Mediators Association of Georgia , presented the 2020 annual report in front of the Association members.

At the General Assembly, for the first time in the history of the Association, the elections of the members of the Ethics Commission of the Association were held and the Code of Ethics of the Georgian Mediators Association was approved.



The office of Mediators Association of Georgia has been technically equipped with the support of USAID/PROLOG, the United Nations and United Nations development program (UNDP). Comfortable spaces were arranged in the association for mediation sessions and individual meetings, the Office is ready to host court and private mediation.






Chairman of the Mediators Association of Georgia and members of the Executive Board met with judges of Tbilisi, Mtskheta and Rustavi City Courts.






The first meeting of the members of the Ethics Commission was held.
